Candidate statement

Candidates are invited to lodge a Candidate Statement to be circulated to members with the 2016 AGM Notice paper. The Candidate Statement can be lodged with the Nomination Form and must be no longer than 450 words (including any headings).

If a Candidate Statement is not received by 5.00pm (Melbourne time) on Monday 24 October 2016, the words 'No Candidate Statement received' will appear in lieu of your statement. If your Statement contains more than 450 words, only the first 450 words will be published. Do not include a photograph.
